Job Title: Workforce Development Specialist

About the Organization: United Way of the Greater Capital Region is a leading non-profit organization dedicated to improving the lives of individuals and families in the Capital Region of New York. Our mission is to address critical community needs by connecting individuals, families, and communities with the resources and support they need to thrive. We are committed to making education and workforce development opportunities accessible to all, and we are seeking a passionate and dedicated Workforce Development Specialist to help us achieve this goal.

Job Description: Beginning in Fall 2023, the Workforce Development Specialist will take on a crucial role in recruiting and partnering with Capital Region BOCES to enroll 45 students in the Electrical Trades, Construction Trades, and Welding & Fabrication programs. This recruitment effort will focus on residents of the South End of Albany and other disadvantaged communities, in line with the criteria set forth by NYSERDA PON 4595 NYS Offshore Wind Training Institute - Workforce Training and Skills Development.

Key Responsibilities:

1. Recruitment and Outreach:
 - Identify and engage individuals from disadvantaged communities and priority populations, including single parents, veterans, previously incarcerated individuals, and English language learners.
 - Develop and execute recruitment strategies, including outreach events, advertising, and community partnerships.
 - Maintain an active presence in the South End of Albany and other targeted areas to build relationships with potential candidates.
2. Eligibility Assessment:
 - Determine candidate eligibility based on residency within disadvantaged communities and priority population criteria as defined in NYSERDA PON 4595.
 - Ensure accurate documentation of eligibility and assist candidates in completing necessary paperwork.
3. Collaboration with BOCES:
 - Establish and maintain a strong working relationship with BOCES to facilitate the enrollment process.
 - Coordinate with BOCES staff to streamline registration and onboarding procedures.
 - Ensure timely transfer of all required materials to BOCES for student enrollment.
4. Candidate Support:
 - Provide guidance and assistance to candidates throughout the enrollment process.
 - Conduct follow-up with students as needed to address any enrollment challenges.
 - Offer support and information to help students succeed in their chosen programs.
5. Data Management:

- Maintain accurate records of recruitment efforts and enrollment progress.
- Generate reports on recruitment activities and enrollment statistics.

Qualifications:

- Bachelor's degree in a related field or equivalent experience.
- Prior experience in recruitment or enrollment coordination, preferably in an educational or workforce development setting.
- Knowledge of New York State's eligibility criteria for disadvantaged communities and priority populations.
- Strong communication and interpersonal skills.
- Ability to work independently and as part of a team.
- Proficiency in data management and record-keeping.
